**Adopting Notice of Exemption from the California Environmental Quality Act for the Paradise Irrigation District Debris Removal Project and Authorizing Staff to File the Notice of Exemption with the Butte County Clerk's Office**

WHEREAS, the Board has determined to carry out the Debris Removal Project (hereinafter "Project");

WHEREAS, the guidelines for the California Environmental Quality Act ("CEQA") exempt certain projects from further CEQA evaluation;

WHEREAS, the Project consists of the removal of debris from structures damaged as a result of the Camp Fire, a disaster for which a state of emergency was declared and the Project is exempt from further CEQA evaluation;

WHEREAS, the District is entitled to file a Notice of Exemption with the County Clerk pursuant to the California Code of Regulations, Title 14, Section 15062; and

WHEREAS, the Notice of Exemption for the Project, is attached hereto.

NOW, THEREFORE, the Board of Directors of the Paradise Irrigation District does resolve, find, and determine as follows:

The foregoing recitations are true and correct;

The Project qualifies for an exemption from CEQA under California Code of Regulations Title 14 Section 15269(a) and California Public Resource Code Section Section 21080(b)(3).
