07/25/22 Board of Directors Meeting

Following is a letter from Consultant Water Works Engineers, which outlines information regarding consideration of Amendment 3 to allow for continuation of the services being provided under the original District Engineering Services Agreement of July 2020.

Staff recommendation is to extend Water Works Engineers District Engineering Services through the end of the fiscal year (June 2023) at an average spend rate of \$5000/month, which is the current spend rate for those services (reduced from a peak average spend rate at the end of 2021 of \$45,000/month).

In order to procure those services from Water Works Engineers, PID needs to increase the contract budget by \$45,000 and extend the contract through June 30, 2023 (a time and budget extension).

Staff recommendation is to proceed with these changes.

If the Board would like to execute the time and budget extension, the recommended form of motion for consideration is:

"I move to authorize approval of Amendment 3 and direct Staff to increase Water Works Engineers contract not-to-exceed amount to \$560,792 for District Engineering Services and extend the duration of the contract through June 30, 2023."



Dear Mr. Lando:

In July 2020, Water Works Engineers was contracted on a time and materials contract, not to exceed \$150,000, to perform District Engineering consulting services. That Agreement contemplated a need from the District of approximately 60-70 hours/month of District Engineering consulting support with a commensurate budget of \$12,500/month. At the onset of the contract, the need for District Engineering support followed this level of effort,

however as the District re-grew as customers returned to service after the fire, the need for district engineering services consistently increased (reference chart). In response to this demand, Amendment 1 to Water Works Engineers District Engineering consulting services contract increased the not to exceed amount to \$450,000 in March of 2021.

In mid-2021, the District recognized the need to bring back the pre-fire District Engineer staff position and in September 2021, Blaine Allen started as the full-time District Engineer. Following Blaine's onboarding, the need for District Engineering consulting support was quickly reduced, as shown in the chart, from a 3month average monthly billing high level of \$45,000/mo to quickly below \$10,000/mo.



In December of 2021, Amendment 2 to Water Works Engineers District Engineering consulting services contract increased the not to exceed amount to \$515,792 to provide ongoing district engineering support at a reduced level. Over the last 6 months, the need for District Engineering consulting services has been approximately \$5000/month (24-36 hours of engineering consulting). It is the District's desire to continue this level of District Engineering consulting services through the 2022-2023 fiscal year. The current contract has just over \$14,000 budget remaining. In order to provide continued District Engineering consulting services through June 30, 2023, the contract budget needs to be increased by \$45,000.

AMENDMENT 3

TO THE AGREEMENT BETWEEN PARADISE IRRIGATION DISTRICT AND WATER WORKS ENGINEERS REGARDING DISTRICT ENGINEERING SERVICES

This Amendment is made and entered into this 26th day of July, 2022 by Paradise Irrigation District, an irrigation district formed and existing under Division 11 of the California Water Code ("District") and Water Works Engineers, LLC ("Consultant"). District and Consultant are collectively referred to as "Parties".

RECITALS

Whereas, on July 15, 2020, parties entered into an Agreement for District Engineering Services ("Agreement")

Whereas, on March 17, 2020, parties executed Amendment 1 to the original Agreement for District Engineering Services ("Amendment 1")

Whereas, on December 15, 2021, parties executed Amendment 2 to the original Agreement for District Engineering Services ("Amendment 2")

Whereas, since that time, parties have identified additional work that must be performed; and

Whereas in accordance with Paragraph XIII of the Agreement, the parties desire to modify the Agreement to reflect changes in the scope of work.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby stipulated, the parties agree as follows:

1. Paragraph III (B)(1) shall be amended to state:

Consultant shall be solely responsible for satisfactorily completing the Project, including those tasks described in Exhibit A, Exhibit A – Amendment 1, Exhibit A – Amendment 2 and Exhibit A – Amendment 3. Consultant shall supervise and direct the work to the best of Consultant's ability and give all attention for such proper supervision and direction.

2. Paragraph VI (A) shall be amended to state:

Payment: Consultant will be paid on a time and materials basis in an amount "not to exceed" \$560,792 for the Project and work to be performed in Exhibit A, Exhibit A – Amendment 1, Exhibit A – Amendment 2 and Exhibit A – Amendment 3. No Work in addition to the work described in this Agreement, including Exhibits, shall be performed by Consultant without prior written authorization by District as provided for in section IX of the Agreement. Progress payments shall be made monthly for work completed based upon the billing rates contained in the Schedule of Rates/Fees attached hereto as Exhibit B – Amendment 3.

Except as modified herein, the provisions of the July 15, 2021 Agreement shall apply.



The purpose of this Amendment 3 to Water Works Engineers District Engineering consulting services contract is to extend district engineering support at that level through the end of the 2022-2023 fiscal year.

SUBTASK 1 – PROGRAM MANAGEMENT

Under this subtask, ENGINEER will provide the following services:

SUBTASK 1.1 – PROJECT MANAGEMENT THROUGH JUNE 2023

Water Works will provide Project Management oversight and reporting of all efforts undertaken under this contract, communicating progress and providing deliverables as requested to meet PID's needs.

Subtask 1.1 - Meetings

Water Works engineering staff will attend planning meetings, meetings with regulators, meetings with contractors and service providers, and public meetings as requested to support PID operations.

Subtask 1.2 - Communication

Our engineers will work with PID staff to provide support in communicating the District's engineering policies and decisions to stakeholders and to the public as needed. This will include producing communication materials, leading public information workshops, providing input on District website updates, etc.

TASK 2 – ENGINEERING SUPPORT FOR THE DISTRICT THROUGH JUNE 2023

For this task, the Water Works Engineers team will engage with the PID District Engineer to provide professional engineering support as needs regularly arise related to ongoing District operations and management. Supporting PID's existing staff resources, Water Works will provide additional technical input where requested, furnishing analyses, reviews, recommendations and planning efforts in such a way as to facilitate the successful execution of the District's goals.

Each request for support will be defined in discussions with PID District Engineer, with Water Works staff working to ascertain the District's technical needs, schedule and milestones, deliverables, as well as any related support with regard to communication or coordination (internal or external to the District).

Our team will engage additional staff resources as necessary to support each request where it might be beneficial, potentially including GIS support, drafting, industry or other subject matter experts as applicable to the assignment.

EXHIBIT C – AMENDMENT 3

INSURANCE REQUIREMENTS

Consultant agrees with the Paradise Irrigation District that:

- a) By his/her signature hereunder, Consultant certifies that he/she is aware of the provisions of Section 3700 of the Labor Code which requires every employer to be insured against liability for workers' compensation or to undertake self-insurance in accordance with the provisions of that code, and he/she will comply with such provisions before commencing the performance of the work of this agreement. Consultant and subconsultants will keep workers' compensation insurance for their employees in effect during all work covered by this agreement.
- b) Consultant will file with the Paradise Irrigation District before beginning work, certificates of insurance and policy endorsements satisfactory to the Paradise Irrigation District evidencing general liability coverage, of not less than \$1,000,000 per occurrence (\$2,000,000 general and productscompleted operations aggregate (if used)) for bodily injury, personal injury and property damage; auto liability of at least \$1,000,000 for bodily injury and property damage each accident limit; workers' compensation (statutory limits) and employer's liability (\$1,000,000) (if applicable); requiring 30 days (10 days for non-payment of premium) notice of cancellation to the Paradise Irrigation District. Such insurance shall be primary and any insurance, self-insurance or other coverage maintained by the Paradise Irrigation District, its directors, officers, employees, or authorized volunteers shall not contribute to it. The general liability coverage shall give the Paradise Irrigation District, its directors, officers, employees, and authorized volunteers insured status using ISO endorsement CG2010, CG2033, or equivalent. Coverage is to be placed with a carrier with an A.M. Best rating of no less than A-:VII, or equivalent, or as otherwise approved by the Paradise Irrigation District. In the event that the Consultant employs other consultants (sub-consultants) as part of the work covered by this agreement, it shall be the Consultant's responsibility to require and confirm that each sub-consultant meets the minimum insurance requirements specified above. Consultant agrees to waive subrogation which any insurer may acquire by virtue of payment of any loss. Consultant shall obtain any endorsement necessary to affect this waiver of subrogation.
- c) Consultant shall maintain errors and omissions liability insurance appropriate to the Consultant's profession of no less than \$1,000,000 per claim and aggregate for this project.
- d) Insurance must be maintained for at least five years after completion of contract work.

Background:

Following direction provided at the June 27, 2022, special meeting of the Board of Directors, the District issued a Press Release on that same date announcing a vacancy exists in the Office of Director, Division 1, of the Paradise Irrigation District. To be eligible to serve as a director, an appointee must be a registered voter within the District and a resident of Division 1 at the time of appointment and through the new directors' entire term (Water Code, § 21100, subdivision (a).).

The District has received communications expressing interest from two eligible candidates. Deliberations of the Board in connection with the candidate to be selected for appointment, as well as any interviews or communications the Board wants to have with the candidate in its official capacity must occur in open session. The Board must affirm an appointment by majority vote in open session.

When, as here, a vacancy occurs during the first half of a term of office and at least 130 days prior to the next general district election, the person appointed to fill the vacancy shall hold office until the next general district election on November 8, 2022, and thereafter until the person elected to fill the seat assumes office in December 2022. The individual elected in November shall serve the remainder of Brian Shaw's original term – until December 6, 2024.

If, for any reason, the Board does not fill the vacancy or call an election within 60 days of the vacancy (August 16, 2022), the Butte County Board of Supervisors shall have the authority to fill the vacancy by appointment. The obligation to call an election becomes mandatory if the seat remains vacant for 90 days, which would be September 15, 2022.

Directors are expected to attend at least one evening Board meeting a month and typically attend an average of two committee meetings a month. The District will make an effort to provide board training, as it is available.




