Mr. Lando. I was advised by the tax collectors office in Paradise irrigation district to write you a letter which I'm horrible about writing letters so anyhow, they said I could send you an email.

I'm going to try to explain my issue clearly to you

l lived at 507 Iris Ln. for 46 years and paid my water bill Faithfully

Last week I received delinquent tax bill and immediately called the tax collectors office

as I had paid my taxes. A very nice woman they named Stephenie advised me that the delinquent tax bill was for my property at 507 Iris Ln., Paradise.

I have not been getting bills for that property Last year. My son helped me find that bill online and I sent the tax collector \$500.

The delinquent tax bill I got was almost \$1200 Stephenie said it was prior years plus Paradise irrigation district charges added to it and penalty's etc.

I had no idea this was happening

Four years ago, I spoke to a girl at your office named Kimberly at that time asked her to please remove the meter from my property and not send me bills anymore which I assume she did. I was very happy it was taken care of for me. she was very very nice. Last week when I got the delinquent tax bill, I called Paradise irrigation district after speaking to the tax collectors office, and I happen to get Kimberly again she remembered me and she told me that she sent me paperwork to sign to get that taken care of

Well, I never got any paperwork and if I did, I didn't realize what it was I just assumed it was all taken care of

Now I was over 80 years old when my property up there and my town burned so you know I'm old now and I won't be moving back up there

In fact, I can't hardly go into paradise without having anxiety attacks

I sat in that fire for 3 1/2 hours knowing I was going to burn alive and not knowing if my son was being burned alive. . I was on my way, trying to get my paralyzed son out of Yankee hill where he was so he would be safe. . They had to turn me around there's no way I could get to Yankee hill. Then I was trapped

Thank God for the first responders they got my son out and also also got me out Anyway, I have no intentions of moving back to Paradise. I don't know what to do with that property. I was going to ask the neighbor if they wanted to buy it but I will eventually put it up for sale.

I was advised to ask you, if you would please reimburse me for all the bills attached to my taxes and discontinue any more bills for water or a meter of what ever at that property

I hope I explain this OK I'm not the smartest person there is, but I tried to make it clear If you have any questions or want any more information, please call me at Thank you so much please thank the girls for being so nice to me. I truly appreciate it. Grace Covington (Bobbie)

Board members reviewed written staff and consultant reports presented in the agenda packet. Discussion included: 1) The Paradise Ridge Chamber of Commerce is hosting The Ridge's first ever Open House Weekend on June 1st and 2nd featuring businesses and organizations from the Ridge community. PID will be participating in this event; 2) A meeting with a delegation from Maui will be held on Saturday, March 23 at 2:45 p.m. at the Paradise Town Hall. PID staff will be participating and providing a presentation; 3) Water Supply Recovery Program Update from Water Works Engineers; and 4) Post Fire Disaster Public Assistance & Recovery Management Services Update from Aptim Environmental & Infrastructure.

PID STAFF & CONSULTANT REPORT UPDATES (Item 6.a. – 6.g.)

Assistant District Manager Mickey Rich reported staff has prepared the proposed amendments to Chapter 7.10 of the PID Rules and Regulations to facilitate the Board request to extend the current Customer Assistance Program (CAP) to up to one water service account for vacant land property owners. Staff recommends making the policy effective for the next billing cycle effective May 1, 2024 with recertification each year.

It was moved by Director Boston and seconded by Director Guillory to accept the proposed amendments to PID Rules and Regulations, Chapter 7.10, Customer Assistance Program, effective May 1, 2024.

Staff reported Paradise Irrigation District recently issued a Request for Proposal (RFP) for Pavement and Concrete Repair Work on District projects. Proposals were submitted by Santos Excavating, Inc. and RCI General Engineering with Santos Excavating being the low bidder.

Scheduled paving work bid as a lump sum in the RFP includes Dora Lee Lane, Woodsdale Lane, Valley View Drive, and a concrete sidewalk repair at Dutch Brothers. The total lump sum cost submitted by Santos Excavating was \$46,465.10. Staff further noted the proposals also contained unit pricing for patchwork that may be required over the next twelve months for PID projects completed in roadways, sidewalks, or driveways.

It was moved by Director Boston and seconded by Director Prest to authorize the District Manager to execute an agreement with Santos Excavating, Inc. to perform necessary Pavement and Concrete Repair Work through April of 2025 for the cost as outlined in their proposal.

Board members reviewed a memo from PID staff regarding the condition of two districtowned properties along Clark Road that have been managed as rentals in the past but are now vacant. Based on necessary renovations for both properties, staff is seeking direction from the Board. Staff noted based on business needs, the District would benefit from making renovations to the house and utilizing as additional office space and either demolishing the commercial building or using for an additional storage option.

Board direction was given to staff to distribute a Request for Proposal to repair the house for use as office space and to demolish the commercial building. Director Boston recommended looking into digitizing all PID records.

District Manager Tom Lando indicated staff would like to hold a budget workshop in May and requested input from the Board on whether they would like to schedule a special meeting or combine with the regularly scheduled Board of Directors meeting on May 15. PID INFRASTRUCTURE DAMAGE POLICY APPROVED (Item 8.d.) Assistant District Manager Mickey Rich indicated the proposed addition to PID Rules and Regulations, Chapter 6, was developed by PID Legal Counsel to address recurring damage to PID infrastructure caused by negligence. PID has historically collected for damage to its system, however, since the Camp Fire, there has been a vast increase in infrastructure damage. This policy seeks to reduce the instances of damage by adding penalty for negligent damage.

It was moved by Director Guillory and seconded by Director Prest to adopt the proposed additions to PID Rules and Regulations, Chapter 6.15.

RE: Award of Contract for Gabion Wall – Magalia Dam Spillway 04/17/2024 Board of Directors Meeting

The District recently issued a Request for Proposals (RFP) for the construction of a Gabion Wall in the Magalia Dam Spillway. This is a repair required by the Division of Safety of Dams (DSOD) as an interim risk reduction measure due to hazards identified in our spillway after inspections triggered by the Oroville Dam Spillway disaster.

Six Contractors submitted proposals with the lowest bid received from McIntosh Equipment.

Staff reviewed all proposals for completeness and checked with McIntosh Equipment for similar projects, related experience, and schedule availability to be able to perform the project. Staff is recommending the Board accept the proposal from McIntosh Equipment to construct the Gabion Wall.

Action Requested:

"Authorize the District Manager to execute an agreement with McIntosh Equipment to construct a Gabion Wall in the Spillway at Magalia Dam for a cost of \$128,900.00, plus an additional 15% contingency value of \$19,335.00 to be executed at the discretion of the District Manager or designated representative."

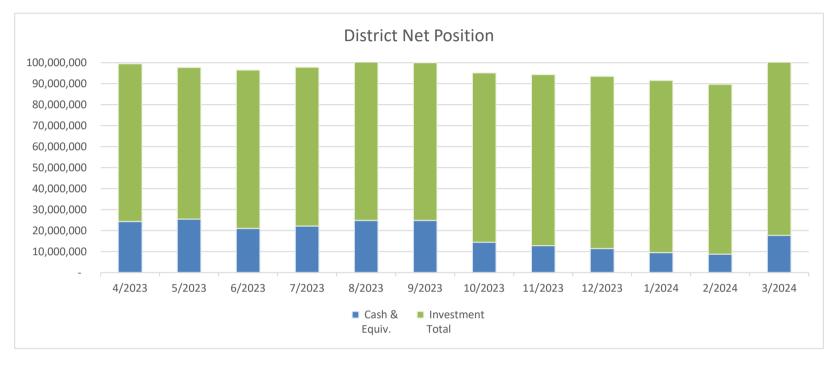

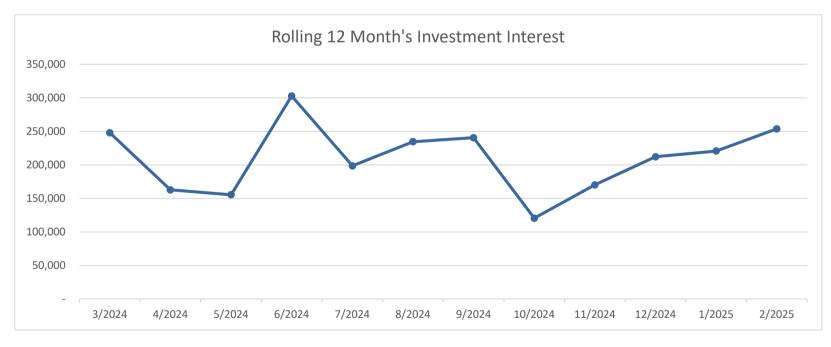
1. Cash, Cash Equivalents, & Investments:

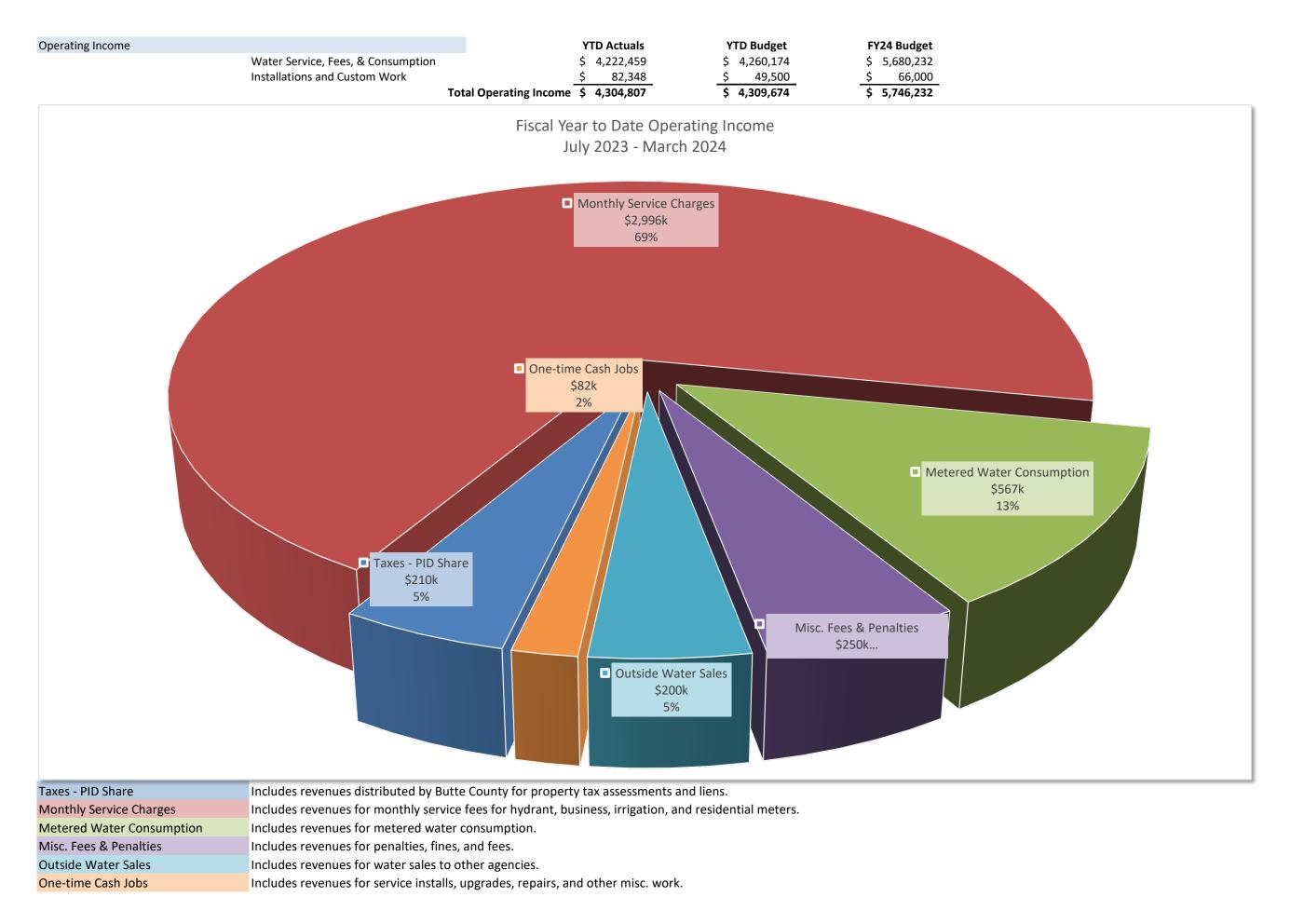

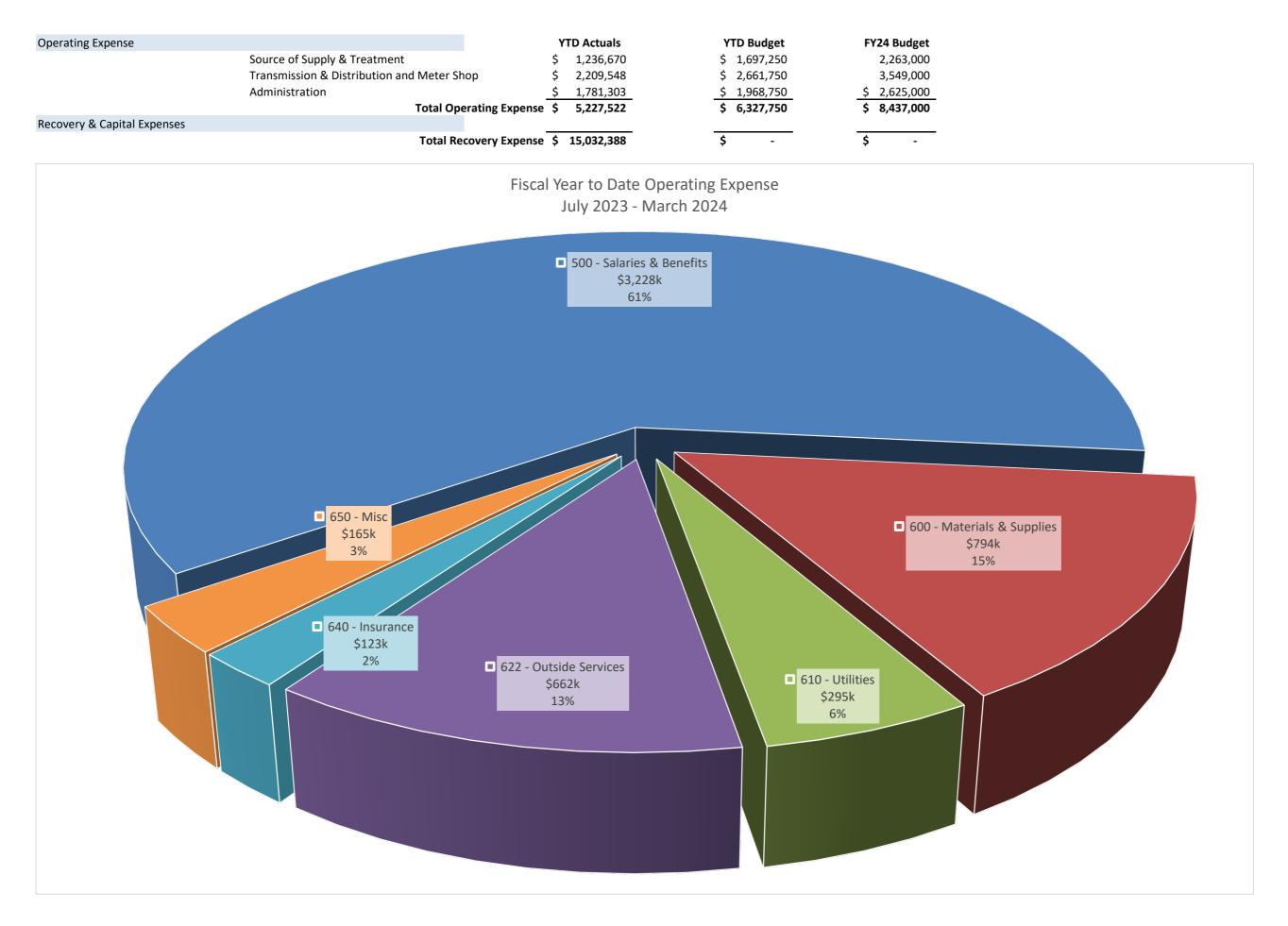

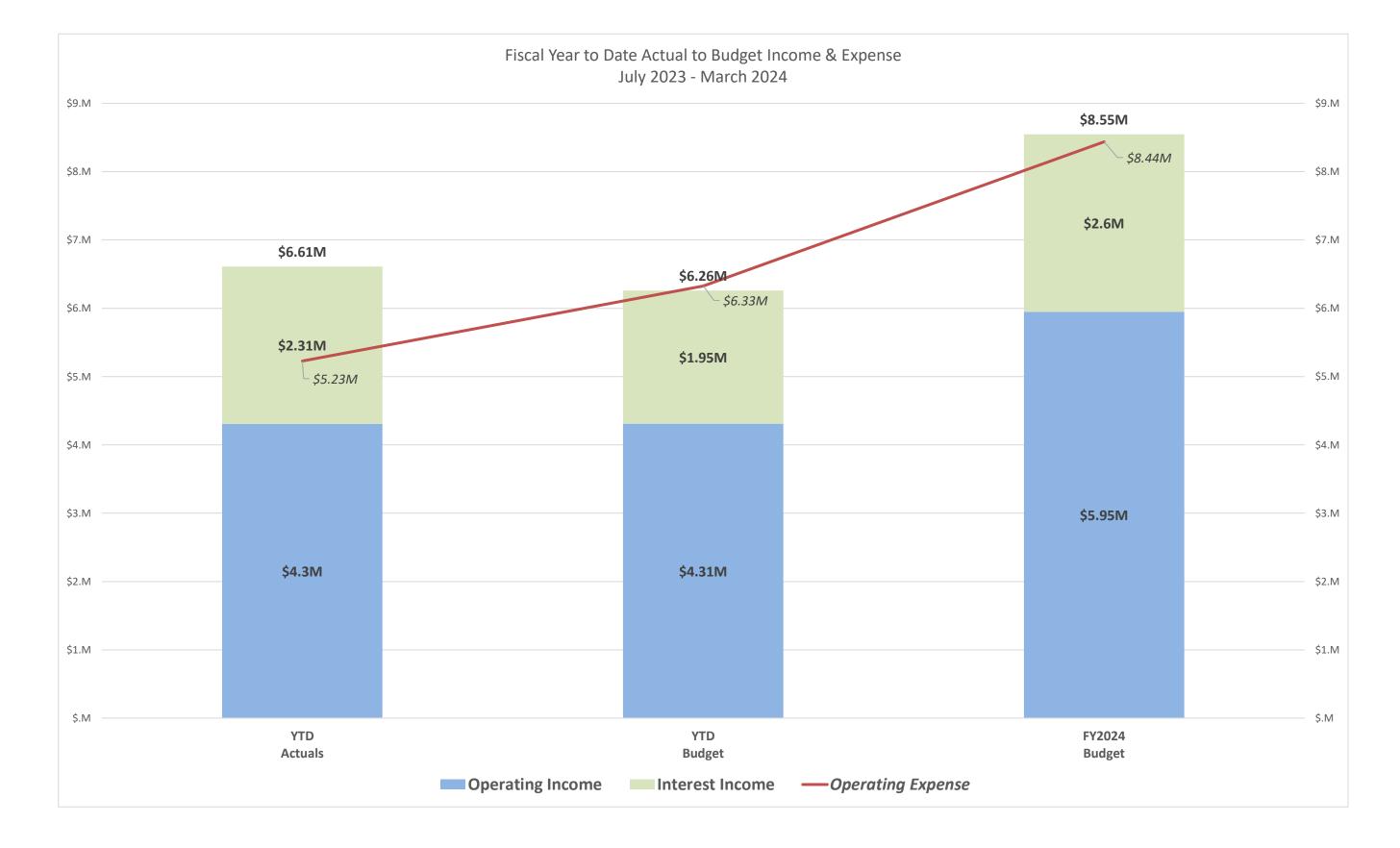

A map would have been nice with some definition of what lands fall within the PID watershed. I am assuming areas around Magalia Reservoir and Paradise Lake but more detail is preferable. I responded "no" for mastication and any use of fire but in actuality I think there may be conditions in which these might be the best choice. For example, mastication might be best for very thick stands of Himalayan blackberry or Scotch broom but should not be used broadly in native understory as it leads to soil compaction, could result in harm to wildlife and is a noise nuisance. Fire may be an appropriate tool at times but I believe should be used as a last resort as there's potential for fires to escape control, smoke and fires are triggering to many Camp Fire survivors, the smoke adds to our already generous exposure to carcinogens and poor air guality and may be harmful to sensitive groups. As a PhD in wildlife management and conservation I am also concerned about the protection of breeding wildlife and habitat during vegetation management activities, for example, cavity nesting and shrub nesting bird species and nesting Bald Eagles and Osprey at Paradise Lake. These protected species have special state and federal guidelines for any vegetation management in the vicinity of their breeding sites that should be followed by PID. Finally, I saw a map in the Magalia Community Center with PID vegetation treatments around Magalia reservoir that showed herbicide treatment right along the eastern edge of the reservoir. While this wasn't a treatment you asked about, I would like to state that I am against the use of any carcinogenic herbicide or use of herbicides directly adjacent to any water body as they often have impacts on aquatic wildlife as well as our human health.

The Trinity Alps and Yellowstone are good examples of not allowing wise timber harvest. This town did exactly the same thing. Then didn't allow watering. In my neighborhood we cut what we wnted and watered. We found out that everywhere we irrigated didn't burn! As a result, our house did not burn! This town burned because the town listened to specialist not the people. Ill manage my own property.

Depending on the exact area, a certain method would be better then others.

this is an cellent approach! Perhaps include a map of the watershed and PID boundaries. A watershed appoach to natural resources management (Including Water) is a logical and effective way to manage vegetation water soil and wildlife habitat.

Funny about the goats- I suggested that long before the fire only to get dirty looks it fell on deaf ears & every excuse to not use them.

I feel the experts in vegetation management know the best method on a given area

Annual water system "flushing" is this spring

Paradise Irrigation District crews will work in each neighborhood this spring to "flush" the water distribution system. PID anticipates completing the system flushing, neighborhood by neighborhood by the start of summer. Cenerally, the flushing will move south through neighborhoods, starting from the "top" northern part of the district. The effects of flushing will generally be noticed only in the immediate area being flushed.

Flushing removes oxidation from inside steel pipes; during flushing the water is forced through pipe sections under high-pressure creating a "scouring" action inside the pipes. The flushed water is released into the roadway ditch.

In your home or business, the water may appear cloudy due to the increased air introduced into the system during flushing. You can see this by opening the tap and getting a glass of water; watch as the cloudiness disappears as the small air bubbles settle out.

While the flushing doesn't affect the safety of the water arriving

PID crews will work to thoroughly flush the water mains but a small amount of residual material may remain until your home lines have leared any discolord water. Crews will work to minimize traffic impact Long-term project begins to replace water mains

Recovery from the Camp Fire continues with the replacement of main water lines throughout PID's service area. The project's first phase, which is anticipated to take about 20 months, updates the district's aging piping infrastructure and provides more reliable service for our customers.

"We'll replace the mains and then reconnect all current Active customer accounts and lots to the main lines," explains District Engineer Blaine Allen. "We've contracted with outside crews for the project and are working closely with the Town of Paradise to coordinate and reduce traffic issues."

Allen says the work will include lane closures and traffic control in some areas for a short time.

"Our goal is to limit the impact on traffic by not taking up entire roads but instead reducing traffic to one lane as needed," he continues. "There may have to be a few road closures but we will work to keep it down to one-lane traffic whenever possible."

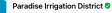

Beginning Monday, March 4, Paradise Irrigation District crews will work in each Paradise neighborhood to "flush" the water distribution system. PID anticipates completing the system flushing, neighborhood by neighborhood, by the start of summer. Generally, the flushing will move south through neighborhoods, starting from the "top" northern part of the district. The effects of flushing will generally be noticed only in the immediate area being flushed.

Flushing removes oxidation from inside steel pipes; during flushing the water is forced through pipe sections under high-pressure creating a "scouring" action inside the pipes. The flushed water is released into the roadway ditch.

While the flushing doesn't affect the safety of the water arriving in your home or business, the water may appear cloudy due to the increased air introduced into the system during flushing. You can see this by opening the tap and getting a glass of water; watch as the cloudiness disappears as the small air bubbles settle out.

PID crews will work to thoroughly flush the water mains but a small amount of residual material may remain until your home lines have cleared any discolored water. To more fully clear your home's lines after your neighborhood lines are flushed, open an outside hose bibb or the bathtub tap and run about 80 to 100 gallons of water (one full bathtub) until the water appears clear.

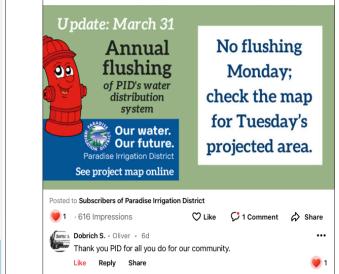

SUMMARY

In A-Zone, on 3/14/24 PID assisted T&S with the completion of connecting the newly installed 16" main to the existing 12". This included draining, refilling and testing the existing portion of main

We have received approximately 75 applications for the vacant Warehouse Position. We have gone through all applications and conducted interviews. We will make our selection in the beginning of April.

On 03/04/24 we started our system wide flushing program. Our crews will move systematically through town from the top to the bottom to clear out every main in our Distribution System. We estimate this should take us approximately five weeks to complete.

On 03/21/24, at approximately 0645 PID was notified about an abnormal pressure spike in the Valley View area. After investigating numerous options, Kurtis Brey inspected the Pressure Reducing Valve in that area and determined there was a failure in the Pilot Control, resulting in unregulated water flowing into D-Zone. This issue was identified and resolved by approximately 1200pm.

In this timeframe, the over pressurization affected approximately 170 customers. The PID Customer Service was quick to notify and inform all customers affected. This also resulted in approximately six customer claims to be filed for various reasons.

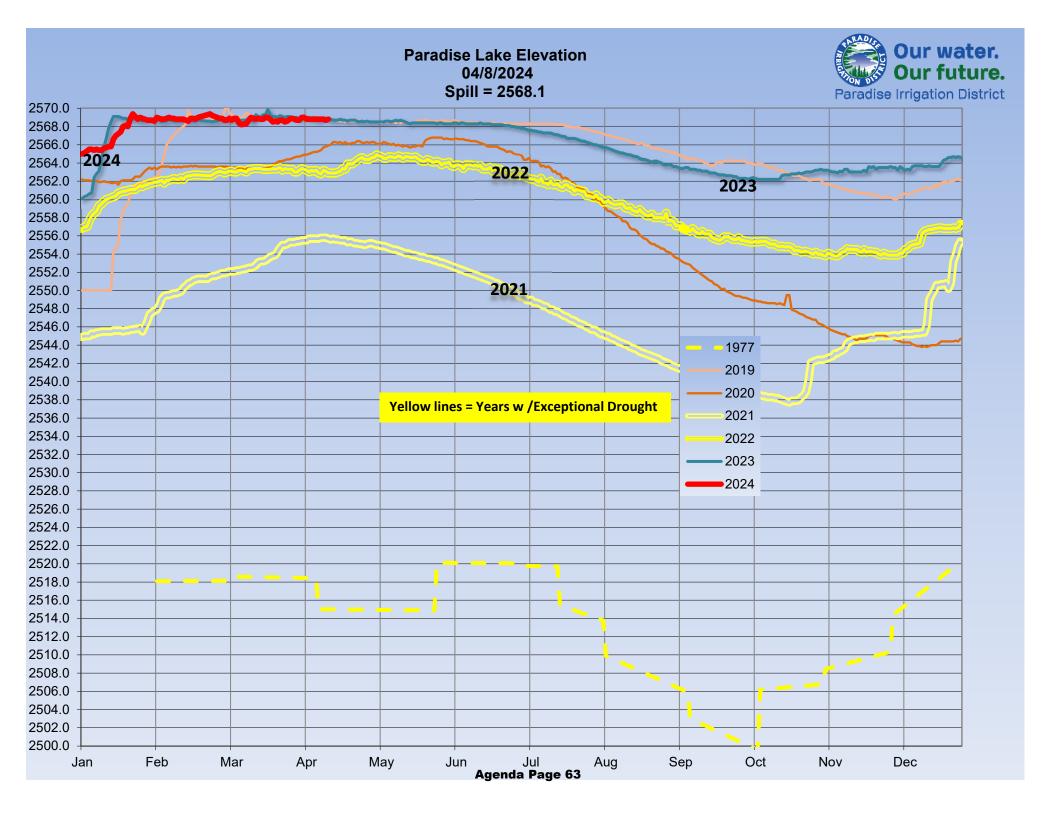

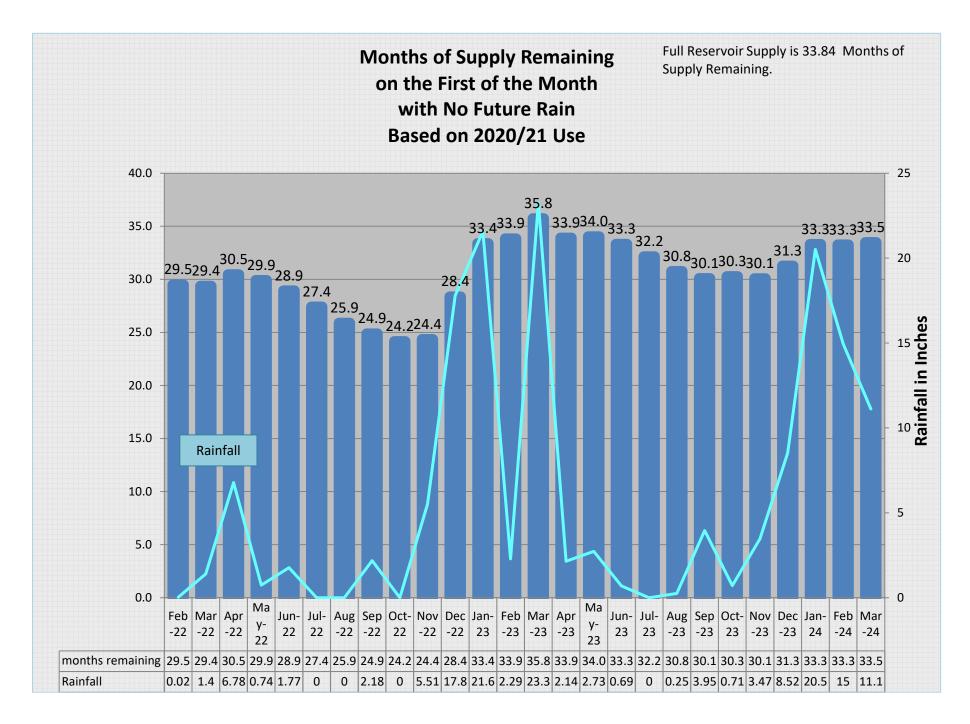

District Engineering Department Update for the Board of Directors

- 1. Working with customers and providing estimates to provide new water meter services to multiple locations throughout town.
- 2. Coordinated with Water Works on MISLR 3 and other projects.
- 3. Working with Slate Geotechnical Consultants for Magalia Dam 100% design. The Design has continued after meeting with FEMA, boring appears to be planned for the May/June timeframe due to driller availability and permit requirements.
- 4. Zone A pipeline is progressing nicely, they are currently working at the treatment plant on the new pump house, they have fully connected the distribution line and poured the footings for the pump house.
- 5. Monthly water reporting is continuously being completed.
- 6. Working with the Town of Paradise as they complete the 2024 On-system road paving that is to be completed in 2024, RCI is working on installing laterals before the paving begins. We completed all the 2023 off-system roads that are being paved in spring 2024.
- 7. Mains project is progressing nicely. Xeno and Judy are complete with multiple other mains to be completed in the next couple of weeks. Once these are completed the contractors sub will come back and do pavement patch work.
- 8. MISLR phase 3 work is completing service laterals with 4 crews, 1 dedicated to building permits and priorities and the other 3 are focused on roads the Town has on their list to be paved in 2024. With the rainy season work has been mostly delayed. We are currently looking into having RCI add an additional crew to stay ahead of the Town's paving project, this crew will begin work once weather has cleared.
- 9. RFP for Gabion Wall construction has been put out and the apparent low bidder will be presented the board at this month's meeting.
- 10. Work on other RFP's including EQ tank project management, rental property updates, and tank recoating are in the process of being prepared to be published.
- 11. Final Design of Equalizer Tank is under review and expected to be completed in the next month.
- 12. Working with Town's contractor reviewing fire hydrants to be repaired with a grant they received.

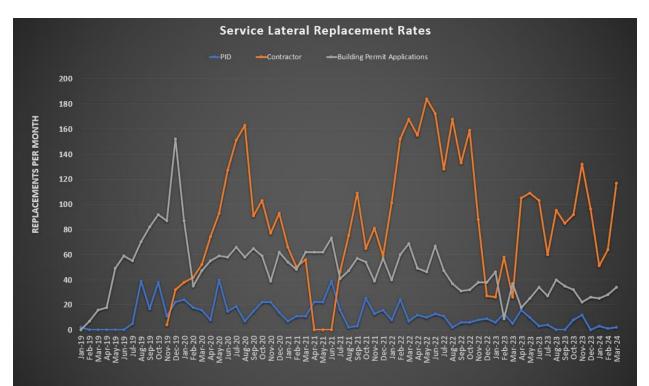

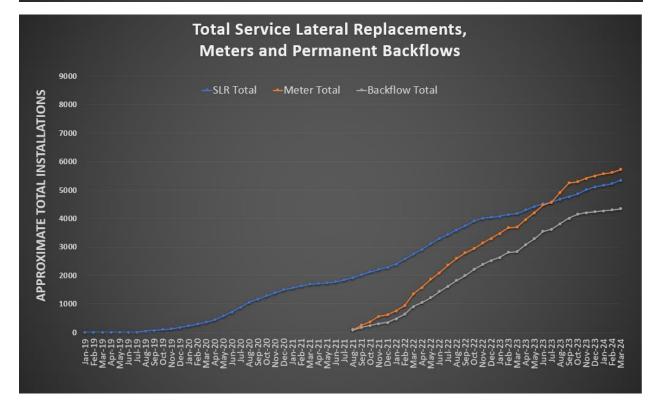
Meter Installation and Service Lateral Replacement Program



- In March the MISLR 3 Project installed the following quantities, impacted by some down time for intermittent weather primarily early in the month:
 - 117 service laterals,
 - 0 100 meters
 - and 51 backflows
- Focus continues to be on 2024 paving priorities for the Town of Paradise project to stay ahead of their work. Continuous coordination with the Town is a priority and data is supplied to support that coordination on a regular interval.
- Additional priority installations to support building permits and urgent requests for water.
- New permit applications at the Town of Paradise came up a bit to 34/month in March although we are seeing a faster approval of submitted permits. These are being incorporated into RCI's workflow with a target of 4 weeks from assignment, weather permitting.
- Work ongoing with PID staff to rectify all active meter/MIU installation records and ensure that this final project phase is a clean sweep of remaining installs.









Main Replacement Project

- Work on the Mains Replacement Project Phase 1 is underway and has continued at a fast pace throughout the month of March.
- 6 new main tie-ins completed to date as of this week, most recently with Farber and Linry.
- Upcoming is the replacement of the A-Zone-1 segment along Cabernet and part of Gate Ln, tying into Clark Road.
- Of note in coming weeks the project will complete the A-Zone-3 segment, tying into the recently installed Zone A pipeline at Skyway.
- West Valley working with Water Works and PID to coordinate main shutdowns as needed.
- West Valley working with the Town of Paradise to coordinate traffic control as needed.
- Several change order request have been initiated by West Valley as they identify unknown field conditons underground. Each request is being analyzed against contract requirements by Water Works and then PID staff to identify necessary costs and minimize future ones.

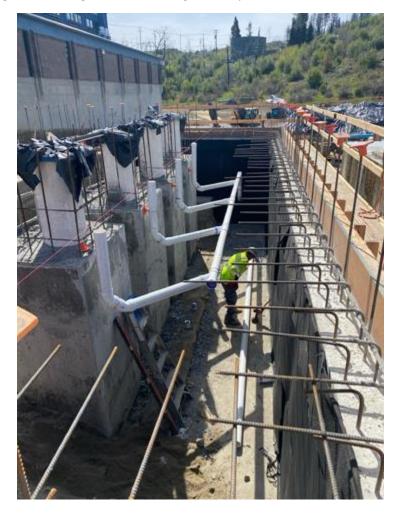

Zone A Pump Station and Transmission Main Project

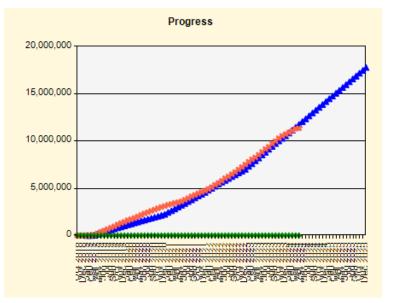
- The pipeline has passed the pressure test and will be chlorinated for tie into the Mains project in the coming weeks. The pump station startup is expected at the end of 2024.

Post-Fire Recovery Update

FEMA Public Assistance (PA) – DR-4407 (Camp Fire Major Disaster Declaration)

The FEMA PA Program provides reimbursements for costs incurred while responding to and recovering from a Presidentially declared major disaster. For this event, the federal cost share was 90% on Emergency Work projects (Categories A-B) and 75% on Permanent Work projects (Categories C-G). CalOES covers 75% of the remaining local cost share, so they pay 7.5% and 18.75% respectively. This typically leaves PID with 2.5% and 6.25% respectively.

For this event, PID was able to claim donated resources and offset the entire local cost share on the emergency work projects. In addition, some of the funding from the Drinking Water State Revolving Fund (DWSRF) is offsetting the local cost share on the major PWs for repairing the water system as well as the replacement Reservoir B when FEMA denied the mitigation proposal. With all funding combined, PID is now only paying a local cost share on recovery-related projects of approximately 0.3%.

Upcoming priorities and recent developments include:

- Financial Dashboard Development Data processing and configuration is ongoing.
- FEMA BRIC grant for Magalia Dam Seismic Retrofit A decision from FEMA is anticipated in August/September.
- New FEMA Declaration DR-4769 Storms The President declared DR-4769 on Saturday, April 13. Working with staff to submit an RPA (Request for Public Assistance), develop list of damages and group into eligible projects. This also means we can begin strategizing for the HMGP funding that stems from this declaration.
- **Reimbursement Requests** Currently gathering supporting contract/task order/change order documentation for the next round of reimbursement requests.

Project was written for the initial phase of service lateral replacements from the Sutton contract. FEMA's titling of the project as "completed outside of 428" led to confusion of CalOES and early payment of funds – notified CalOES of the issue and they decided not to pursue correction of the issue since the work had already been completed. Working on resolving the Sutton change orders to get ready for project closeout – the increase in eligible costs will be submitted at closeout for extra reimbursement, which is expected to surpass the amount of CalOES' overpayment. Sutton issues appear to be resolved and we will file for reimbursement as soon as final payment is processed.



FEMA Hazard Mitigation Grant Program (HMGP)

The FEMA Hazard Mitigation Grant Program is a competitive grant program tied to major disaster declarations. The program provides mitigation opportunities for facilities that were not damaged by the event, but that could be hardened against or protected from a similar type of event.

For the DR-4407 (2018 Camp Fire) HMGP cycle, PID submitted four applications. One application was allowed to partially move forward as an Advance Assistance HMGP grant, for the study and design of the options to restore Magalia Dam. For the DR-4344 (2017 Wildfires) HMGP cycle, PID had submitted an application for a generator at the WTP, as well as pipeline and pump stations improvements. This grant was suddenly revived in early 2022, and we just received the formal award notice this month.

This grant (applied for before the Camp Fire) was awarded in September 2022, for a new generator at the WTP, plus pipeline and pump station upgrades for Zone A. This is also known as the ZAPS Project. PID staff are working to review/revise the 5-year-old cost estimates to determine if a budget increase request is needed. The RFPs for this scope have been reviewed for FEMA compliance, and we have located the HUD terms and conditions to add as well.

Advance Assistance – Magalia Dam Study and Design

The study phase of this grant was completed in early 2022. PID has received an extension to the period of performance and requested a budget increase approval from FEMA. We've been informed that the available bucket of funding is smaller but that PID may request the full amount remaining, and have revised our request to do so. The design contract was approved, so that design may be accomplished in time to apply for the 2023 BRIC funding cycle. CalOES has asked that coring sample work be stopped at the request of FEMA. The REC was approved by FEMA and Slate is moving forward with their geotechnical work. With approval of the REC, the budget increase should move forward soon.



California Drinking Water State Revolving Fund (DWSRF)

The California DWSRF has awarded funding to PID, through a mixture of ASADRA and other funding sources, to accomplish the following tasks:

- Fund the Almond Street project (completed)
- Fund the replacement of Reservoir B (begun)
- Fund the local cost share of FEMA PA PWs related to the recovery of the water system (PWs 332, 333, 349 and 355)

We are working to pull all the documentation and develop a management plan that meets requirements for reporting, reimbursement, and any scope or schedule changes. We are also looking to pursue additional DWSRF grants to fund the added cost of rock removal at Reservoir B. We met with Bow Reilly at DWSRF, who confirmed that additional funding is available and can be requested to cover cost increases. A reimbursement for the available amount of DWSRF funding was submitted at the end of March. DWSRF and Brett requested and processed an amendment to add \$5M of available excess funding to the grant – this should address cost increases since the FEMA PWs were initially obligated. We will be submitting reimbursement requests for the same time periods that we request FEMA reimbursements, to keep the matching costs cleaner.

HUD Community Development Block Grants (CDBG-DR, -MIT)

California Department of Housing and Community Development (HCD) released the allocations for CDBG-Disaster Recovery (CDBG-DR) in August 2022. Of the \$14M we submitted in requests, we are received an allocation of approximately \$3.25M. One project (the portable water treatment truck) was ruled ineligible. Several projects contained scope elements that are in the newly awarded HMGP grant, so those will be included with the Magalia Dam HMGP grant in our submission to CDBG-MIT for FEMA HMGP Match.

We met with the Town of Paradise and HCD on Wednesday 11/16/22 to discuss how information and financials will flow between PID, the Town (as the main applicant) and HCD. As of that meeting, the Town and HCD had not finalized their agreement, and our next steps are based on the finalization of that documentation, which is not expected until early next year. We met with HCD on 1/17/23 to discuss the form to prove Urgent Need and contract requirements (David-Bacon, Section 3, etc) for work we plan to fund through CDBG-DR and CDBG-MIT. On 2/13/23, the Town indicated they still hadn't seen an MSA to review. On 7/5/23, the requested CDBG Project Descriptions have been provided to the Town. Final paperwork has been received regarding the subagreement with the Town, and we are now waiting on HCD to finalize and approve the tank relining project.

FEMA Building Resilient Infrastructure and Communities (BRIC)

The BRC NOI was submitted August 18, 2023. We completed and submitted the 2023 BRIC application to CalOES on December 13. CalOES issued RFIs on December 19-20, and we submitted our responses on January 5, 2024. We fulfilled a smaller RFI on February 12, and final inundation documentation on February 24. CalOES approved the Application and it was sent to FEMA before the February 29 deadline. We received seven letters of support, from Congressman Doug LaMalfa, Butte County Department of Public Works, Butte County Fire Safe Council, Paradise Ridge Chamber of Commerce, Paradise Unified School District, Rebuild Paradise Foundation, and the Upper Ridge Community Council.

Paradise Irrigation District received a letter addressed to the Board of Directors on March 18, 2024, from Renee and Benjamin Moore seeking assistance from the District to relocate a main that runs through their property located at 5075 Eden Road in Paradise. This communication was presented with the complete agenda packet for the March Board of Directors Meeting and recommended for discussion at a future meeting.

The following is a summary of options for replacement of the water main:

The main running near Eden Road is known as a backyard main as it runs through multiple properties instead of along a roadway. In 2007, part of this main was replaced and a "future" connection was installed to continue the upgrade in the future. The portion replaced is north of said property. Currently, PID has an easement running through the properties as that was how it was installed and then granted over to PID. The older portion of the main is two inches or smaller and serves eight properties; where presently, we try to have five or less properties off this size of main.

It would be my recommendation that PID obtain the easements to run a new main (1300 ft) down Eden Road. **(Option 1)**. This would make it easier to access repairs for the future and abandon from the backyards of PID customers. A very rough estimate to do this is about \$450,000 to \$550,000, not including the cost of obtaining the required easements.

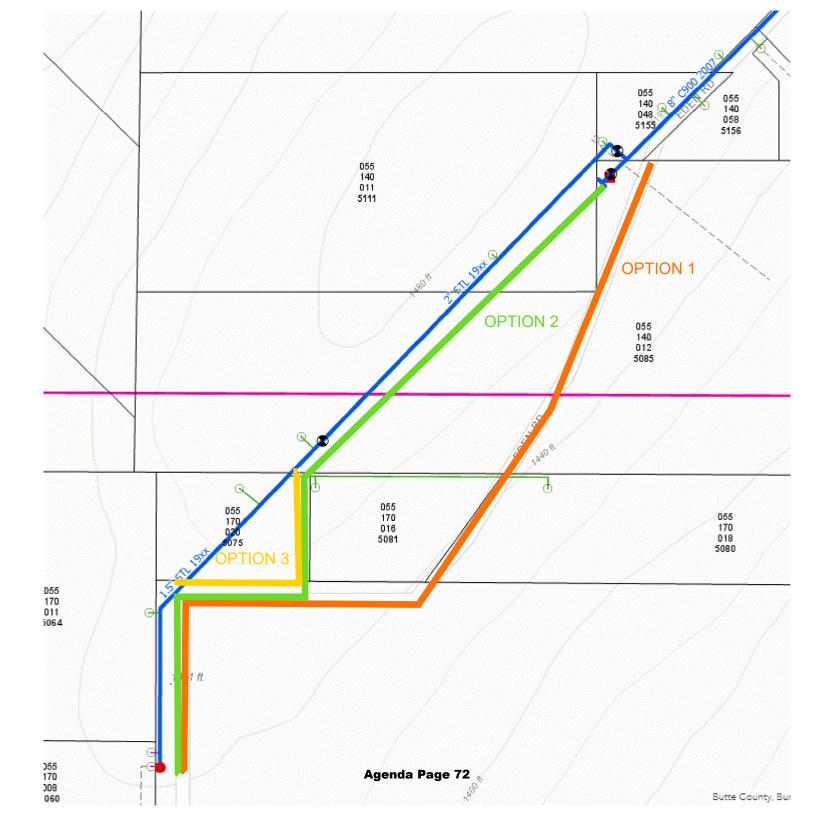
The other possibility as **(Option 2)** would be to install the main within our current easements (1250 ft), with a potential variation where new easements would be granted to change the direction for 5075 Eden Road. A very rough estimate would be \$430,000 to \$530,000.

Strictly relocating the main (350 ft), which is currently a 1-1/2" main on the property of 5075 Eden Road is not advisable **(Option 3)**. It would not be up to our current standards and would not be advantageous for anyone, but this particular property owner. There is not any advantage to the District going this route. A very rough estimate would be \$100,000 to \$150,000. There could also be major obstacles given this has been private property and we do not know what has been installed in this area.

If the Board desires to pursue this as a future project, the suggested form of motion would be:

"I move to authorize PID staff to further evaluate Option ____ as a future main replacement project at Eden Road."

Dear Board of Directors,

My son Benjamin and I are Camp Fire Survivors. Our story and are scars are not much different from the many lives that have been affected by the Camp Fire.

For the last six years, we have done what many have done. Simply survived with our struggles and hopes and dreams. I am a 65 year old disabled woman and my son has helped me get through all of the challenges that we have faced since the fire. We lost our home, as so many have and have worked hard to overcome the disaster that claimed our way of life and our dreams for a beautiful life in the town we love.

Two years ago, we began working with Recover CA and have been awarded a manufactured home to be placed on our land on Eden Road. With the help of RecoverCA, the Town of Paradise, The Camp Fire Collaborative, and Northern California Catholic Services, we have slowly moved toward our of dream of owning a home again and staying in Paradise.

Our home should be completed this Spring. Construction on the land has started. And we have come up with a challenge that we hope you can assist us with.

On or about February 12, 2024, we discovered a main water line that has been on our property since before Paradise Irrigation District even existed. All surveys of the land were completed and there was no mention or knowledge by the Town of Paradise or surveyors of a main water line that supposedly feeds several properties around us. An

easement was potentially detected but no known water main was indicated. No one could have possibly known this existed prior to us purchasing our land. The main was, it seems, put in many years ago before the area was developed as it is today.

The water main goes though the majority of our property. Almost cutting in half of the .85 acre property. We had plans in the future of building on the land that we hope to have in our family for years and years to come. This water main prevents us from attaining those goals.

We spoke to the Town of Paradise and they recommended that we ask you to add our property and this water main to your list of projects that you currently have. It is not currently on the list. Obviously, we are not in a financial situation to take on the financial burden of incurring the cost it would take to make the adjustments (even brief adjustments) to this issue. So, therefore, we come to you for help.

We are in no hurry to have an adjustment to the area affected by this water line. And in fact, we have no objections to having this water line on our property. We are, however, asking to have the line re-routed a bit to allow us to build on our property in the future. We realize the extensive work your company is undergoing to improve the Town and the water service to our neighbors and citizens. Once again, we are asking for a review of the situation and help from you for a solution to our problem for future additions to our property which is zoned for ADU's, horses etc. Which is why we bought this particular property.

I have attached the original survey for our property for your review, as well.

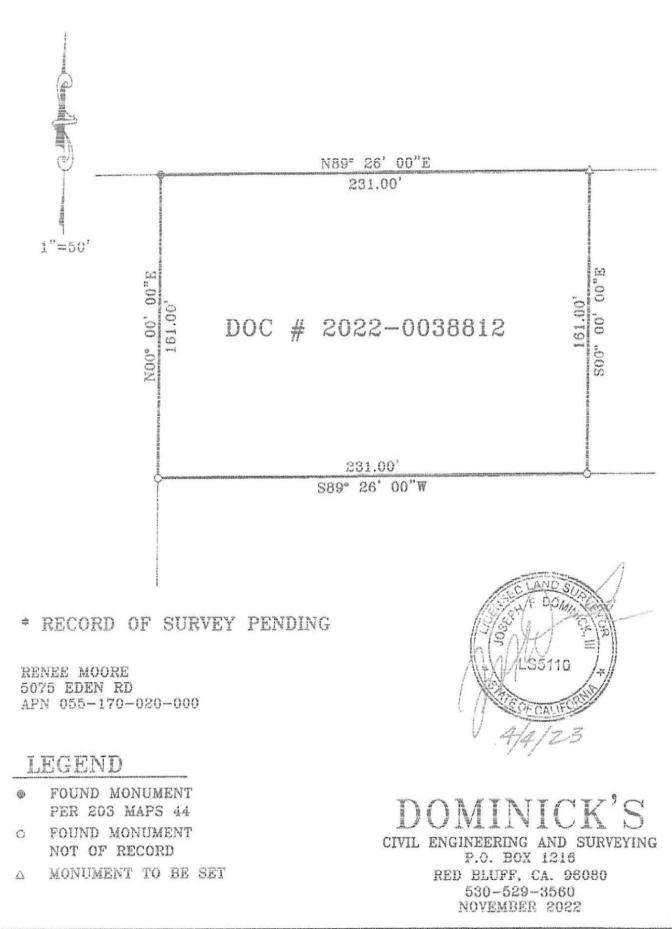
