Paradise Irrigation District Paradise Lake and Recreation Committee Meeting Minutes 6/13/2018

Directors Present: Bill Kellogg, Marc Sulik

Staff Present: Greg Dobbs, Jim Passanisi

Committee Members Present: Darrell Wilson (BCFSC), Dave Bermann, Kieran O'Leary (SPI)

1. Water Supply Update: Jim stated that Paradise Lake is still nearly full, only ½ foot below spill level.

2. Paradise Lake Boat Launch No. 1. Kieran offered to work up the Timberland conversion permit of the 3 acre parcel that was recently purchased by PID from SPI. The idea is to start clearing the trees and brush off of the site. PID crews could do the work after pipeline season is over and there is more time available for District crews schedule wise. The Committee looked at two different parking lot configurations for the site, one north-south oriented, and the other east- west oriented. The Committee consensus was the north-south orientation was preferable. Jim volunteered to work up a conceptual parking lot plan to be presented to the Board at an upcoming regular Board meeting. Director Kellogg brought up the idea of spraying brush and vegetation with Garlon. It might be possible to have the District contract vendor for weed control to perform this. The Committee agreed that public notification regarding any future spraying would have to occur before the spraying would commence. Jim noted that as a public agency, we might have to have a spraying safety plan.

3. Kids Fishing Day (KFD) Financial Summary: Jim presented the financial report. A total of \$11,838 was spent on KFD (volunteer labor excluded). Of that total, \$7,980 was donations and grant monies, which left a total of \$3,858 that the District paid for. It was suggested that the District send thank you notices to all the businesses that made donations to KFD.

4. Project Updates: Greg is working on the bulletin board at Paradise Lake and had discussion with USFS to use some of their images of wildlife for the lake bulletin board.

Greg noted daily parking passes and permit sales are up from last year.

An ADA handicap picnic table will be installed sometime this summer in the lake picnic area. Jim will look into the cost of the ADA picnic table.

The shaded fuel project work with Cal Fire is ongoing. Work has been started on a PID 4 acre parcel near Lucretia Drive.

Greg brought up the idea of having a future ADA handicap fishing spot that would be wheelchair accessible.

Director Kellogg brought up a conceptual idea of having a bottled water plant at the District well site. After some discussion regarding the idea, the Committee decided there were too many obstacles to overcome in implementing such a project.

The next PLRC meeting was set to be held on August 8th at 9:00 a.m. The meeting is to be held at the WTP and include a walking tour along the right-of-way of the 42" main distribution line to town.
